MAINTENANCE

- Weekly lagoon inspections completed.
- Aerators are in the ponds. Two in pond one and one in pond two.
- Sprinkler heads are working well. But don't cover the whole field.
- Snowblower is in summer storage.
- The facility is discharging.
- The new discharge flow meters have been installed and calibrated.

Cummins Backup Generator

- Monthly and weekly inspection and maintenance completed.
- Wasp removal is an ongoing battle.

CONSIDERATIONS

- We will have to order at the least 10 more pumps to cover the duplex stations.
- Send a letter explaining the brown out and the damage done.

OTHER NOTEWORTHY EVENTS OR ACTIVITIES

- Fence repairs are ongoing.
- Lawn care has started and the mower is working fine at this time.
